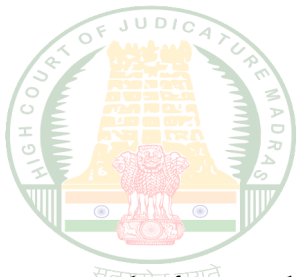

The other conditions shall hold good.
