This Criminal Original Petition has been filed to direct the learned Principal District and Sessions Judge (PCR), Theni to accept the surrender of the petitioner and consider his bail application on the same day on merits in relating to Crime No.78 of 2025 on the file of the second respondent police

2. Heard the learned counsel appearing for the petitioner, the learned Government Advocate (Crl.Side) appearing for the respondents 1 and 2 and perused the materials available on record.

3. In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration the limited prayer and the facts and circumstances of the case, there shall be a direction to the learned Principal District and Sessions Judge (PCR), Theni to consider the petitioner bail application, preferably on the same day of his surrender in connection with Crime No.78 of 2025 on the file of the second respondent police and pass appropriate orders, in accordance with law, after affording due opportunity to the victim under Section 15-A of the SC/ST Act. petitioner shall surrender before the concerned jurisdictional Court, within a period of fifteen days, from the date of the receipt of a copy of this order.
