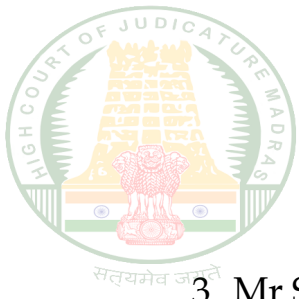
PRAYER :-

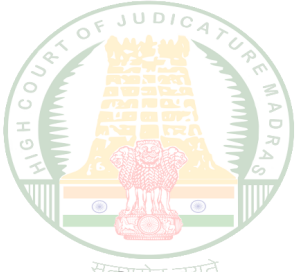
