In view of the said submissions, the respondents 4 and 5 are directed to conduct inspection and survey in the above mentioned property and identify the encroachments if any and thereafter evict the encroachers by following the procedures as contemplated under the statute rules in force. The said exercise shall be completed within a period of twelve (12) weeks from the date of receipt of a copy of this order.

4. The writ petition is disposed of with the above observations. No costs. Consequently, connected miscellaneous petitions are closed.
