ORDER

(Order of the Court was made by J. NISHA BANU, J.)

By consent of both parties, this Writ Petition is taken up for final disposal at the stage of admission itself. Considering the limited relief sought for by the petitioner, notice to the seventh respondent is dispensed with.

2.It is the grievance of the petitioner that her representation dated 10.04.2025, seeking to take immediate action against the seventh respondent and remove the encroachments made by the seventh respondent in the public street in Survey Nos.877/19 and 877/23 and unauthorized construction in Survey No. 877/20 situated at Ayan Vadamalapuram Village, Ettaiyarpuram Taluk, Thoothukudi District, is kept pending till date without any progress. Therefore, she has filed this Writ Petition with the aforesaid prayer.

3.The learned Additional Government Pleader appearing for the respondents 1 to 3 submits that the representation of the petitioner would be considered and appropriate orders would be passed on its own merits within a period that may be stipulated by this Court.

4.Considering the limited scope of the prayer sought for by the petitioner, without expressing any opinion on the merits of the claim made by the petitioner either in the representation or in the affidavit filed in support of this Writ Petition, we direct the respondents 1 to 5 to consider the representation of the petitioner dated 10.04.2025, after giving sufficient opportunity of personal hearing to the petitioner and the seventh respondent and pass appropriate orders on merits and in accordance with law within a period of twelve (12) weeks from the date of receipt of a copy of this order.

5.With the above direction, this Writ Petition is disposed of. There shall be no order as to costs. Consequently, connected Miscellaneous Petition is closed.
