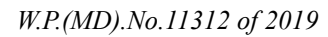

ORDER

This Writ Petition is filed for Mandamus to direct the respondents to approve the appointment of petitioner's service as BT Assistant in the 5th respondent School with all attendant service benefits including the arrears of salary and allowance, during the period between 01.06.1984 to 31.05.1997, in terms of the Division Bench of this Court dated 24.03.2008 in W.A.Nos.1329 of 2000, etc., batch, more particularly in W.P.No.3655 of 1987.

2. The petitioner was appointed as a BT Assistant in the fifth respondent School on 01.06.1984. The fifth respondent School is a minority institution and the School was awaiting sanction of the post for the purpose of getting grant from the Government. Earlier, there were several litigations seeking sanction for
