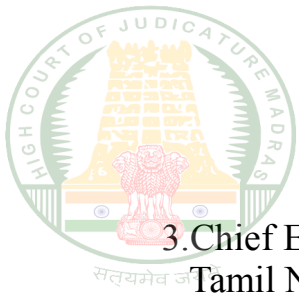

B.P.(FB)No.17 dated 05.07.2003 on the file of the respondent No.3 and fill in the backlog vacancies in the post of Junior Engineers(II) from the Technical Assistants cadre forthwith, within the time period stipulated by this Court.

ORDER

It is reported by the learned counsel for the petitioners that the relief sought for in the present Writ Petition is relating to promotion of the petitioners. It is also submitted that the petitioners are subsequently promoted to the next level post. However, the challenge with regard to the eligibility of promotion is

There shall be no order as to costs. Consequently, connected miscellaneous petitions are closed.
