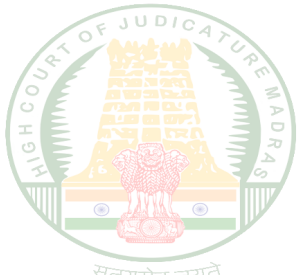

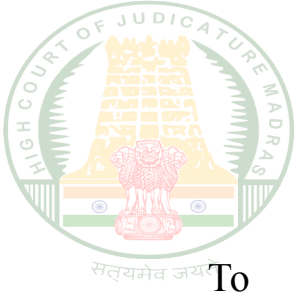
2.Today(05.06.2025), when this writ petition is taken up
