The said exercise shall be completed within a period of eight weeks from the date of receipt of a copy of this order.

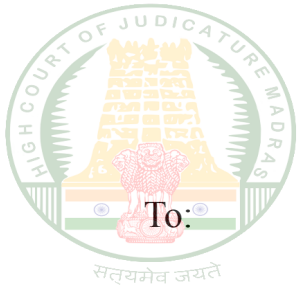
4.With the above observations, this Writ Petition is disposed of.
