Taking into consideration the facts and circumstances of the case on hand, the third respondent / Revenue Divisional Officer is directed to conduct a field inspection in the subject property and take appropriate action by following the procedures as contemplated under law, if any encroachment, illegality or otherwise is found in the subject property.
