ORDER

This Writ Petition has been filed challenging the impugned Government Order dated 23.03.2022, issued by the first respondent. According to the petitioner, as per the impugned Government Order, surplus teaching staff has been appointed for Annamalai University. Hence, the same is illegal.

The period of three years has already come to an end by the lapse of time from the date of the impugned Government Order. Since the period has come to an end, nothing survives for further adjudication in this Writ Petition.

However, liberty is granted to the petitioner to file a fresh Writ Petition, in case the respondents pass a similar impugned Government Order in the near future. There shall be no order as to costs. Consequently, connected miscellaneous petitions are closed.
