3. When the matter is taken up for hearing the learned counsel appearing for the respondents submitted that the CCTV footage was handed over.

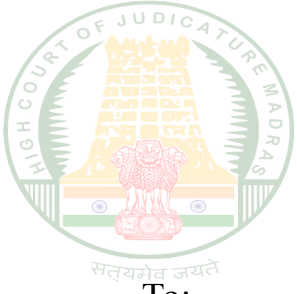
4. Recording the aforesaid submission, this Writ Petition stands closed.
