2. The grievance set out in the writ petition shows that some persons

have submitted forged regularisation order for confirmation of their services.

Since it is a service matter Public Interest Litigation is not entertained. In respect of the allegation of forged submission of documents, the departments have to verify the same, if necessary, by registering an appropriate complaint.

3. With this observation, the writ petition is disposed of. No costs.

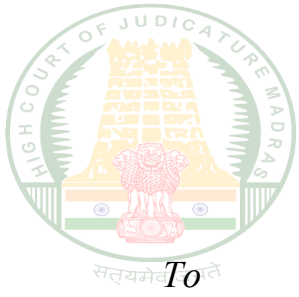
Consequently, connected miscellaneous petition is closed.
