WEB COPY 2. Heard the learned counsel for the petitioner and the learned Additional Government Pleader appearing for the respondents 1 and 2.

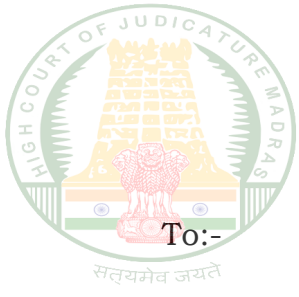
3. Though the petitioner has sought the above relief, it is informed that the impugned orders are only show cause notices. It is therefore open to the petitioner to submit her explanation to the said notices.

4. In view of the above, the petitioner is directed to submit her explanation to the show cause notices before the first respondent within a period of two weeks from the date of receipt of a copy of this order. Upon receipt of the explanation, the first respondent shall consider the same and pass appropriate orders on merits and in accordance with law within a further period of four weeks thereafter.

5. With the above directions, these writ petitions are dismissed. No costs. Consequently, connected miscellaneous petitions are also dismissed.
