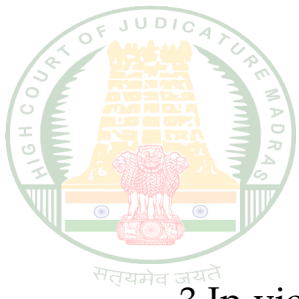
Prayer in CRL A(MD). 354/ 2025 :

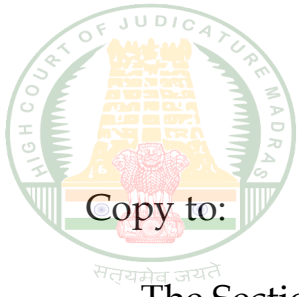
