The petitioner claim to be a purchaser of the lands in respect of which, survey has been directed by an order passed by me on 11.03.2025 in W.P(MD)No.6430 of 2025 at the instance of one Sivakamu Ammal.

Mr.N.Mohan, learned counsel appearing for the petitioner fairly submits that since the petitioner herein was not made a party, he has an objections with regard to the survey, however, would state that since survey has already been directed, under the guise of survey, there shall be no dispossession of the party.
