This Writ Petition is disposed of directing the second respondent to conduct survey and dispose of the petitioner's application dated 01.04.2025 with the assistance of the 3rd respondent officials. The survey shall be conducted in the presence of the petitioner and also neighbouring land owners, who may be affected / interested parties and survey shall be proposed, after hearing their objections, if any. The said exercise shall be completed within a period of twelve (12) weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
