The relief sought for in this writ petition lost is relevance on account of efflux of time. Further, this Court cannot direct the authorities concerned to take efforts to form parks and playgrounds. They are all to be made by following due procedures and considering various other factors.

2. The petitioner cannot seek a direction to form park and playground in a particular survey number and place and the said claim

cannot be considered as the right of a citizen. It is for the authorities concerned to choose the place for forming of parks and playgrounds in the interest of the people residing in the locality. Thus, the relief as such sought for in the present writ petition cannot be granted.
