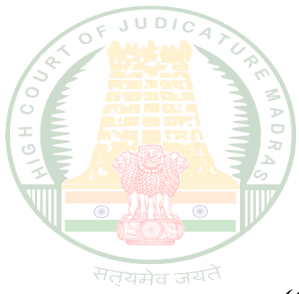

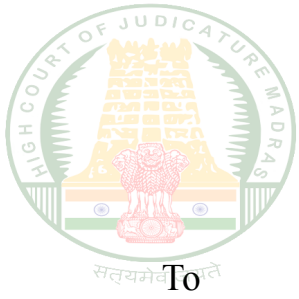
The relief sought for in the present Writ Petition is to direct the respondents 1 to 5 to remove the unauthorized construction.
