2. Recording the same, this writ petition stands disposed of as infructuous. No costs. Consequently, connected miscellaneous petitions are closed.

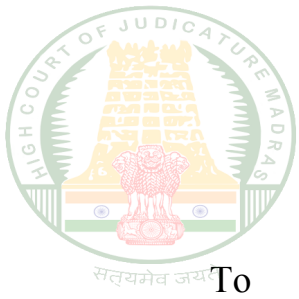
