WEB COPY ORDER: The Court made the following order :-

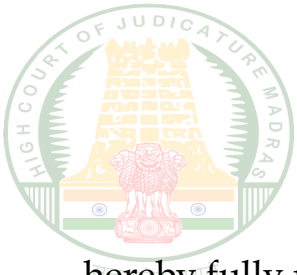
This Petition has been filed to relax the condition imposed in the order passed by this Court in in Crl.OP.(MD)No.3936 of 2025 dated 11.03.2025.
