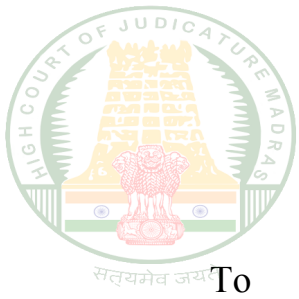
2. Thus, the cause became vanished. Accordingly, the writ petition stands closed. No costs. Consequently, the connected miscellaneous petition is closed.
