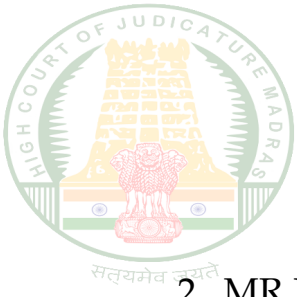
PRAYER :-
