ORDER : The Court made the following order :-

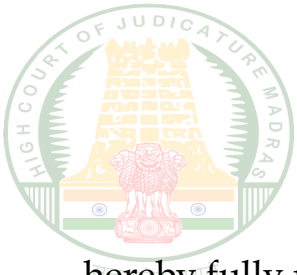
This Petition has been filed to relax the condition imposed in the order passed by this Court in Crl.O.P.(MD) No.3025 of 2025 dated 21.02.2025.
