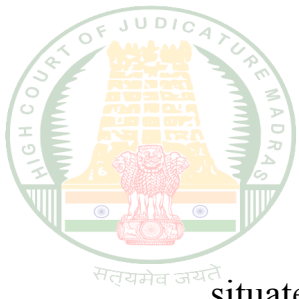

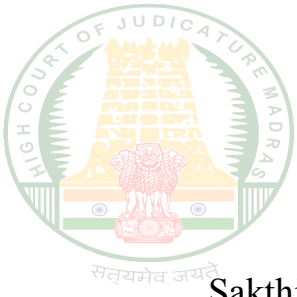

3.The learned Government Advocate (Crl.Side) appearing for the respondents would submit that they have received the representation of the petitioner and they will conduct enquiry and take appropriate action in accordance with law.

4.This Court heard learned counsels appearing on both sides and perused the materials available on record.

5.Considering the nature of relief sought for by the petitioner and since the representation of the petitioner, dated 16.04.2025 is under enquiry before the 3rd respondent and so far no action has been taken, it is deemed to be permitted.

7. With the above said observations and directions, this writ petition stands disposed of.

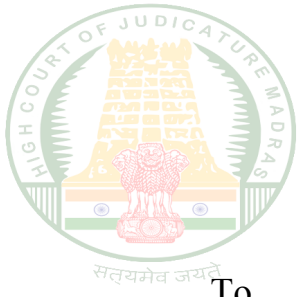
