(Order of the Court was made by ***S.M.SUBRAMANIAM, J.***)

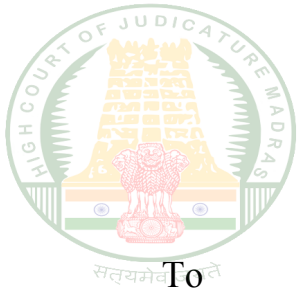
The learned Government Pleader appearing for the respondents 1 to 3 would submit that the impugned resolution has been cancelled subsequently during the pendency of the writ petition.
