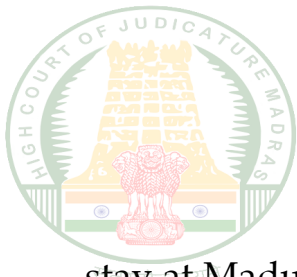
This Petition has been filed to relax the condition imposed in the order passed by this Court in Crl.O.P.(MD)No.5525 of 2025 dated 03.04.2025.

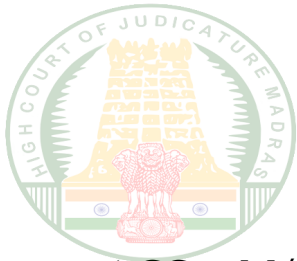
