In fact, I had also through my order dated 23.09.2025 passed in W.P.(MD)Nos.10657 to 10665 of 2021, had followed the order dated 14.03.2024 passed by the Principal Seat in W.P.No.13033 of 2020 etc., batch and dismissed the aforesaid batch of Writ Petitions. Since the petitioner is similarly placed, this Writ Petition has also got to be dismissed.

2.Accordingly, this Writ Petition stands dismissed. There shall be no order as to costs.
