(Order of the Court was made by ***S.M.SUBRAMANIAM, J.***)

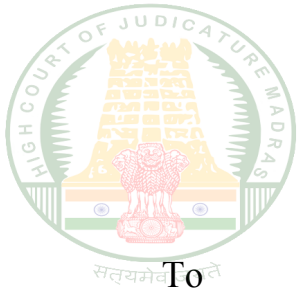
The learned counsel appearing for the respondents would submit that nothing survives in the writ petition.
