ORDER

This petition has been filed by the petitioners to call for the records pertaining to the First Information Report in Crime No.171 of 2025 dated 11.03.2025 on the file of the first respondent police, for the offences under Sections 296(b) and 351(3) of BNS and Section 25(1A) of Arms Act and quash the same.

2. When the matter was taken up for hearing, the learned counsels on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant and all the accused are present and this Court enquired about the terms of compromise. The defacto-complainant
