(MD)No.16683 of 2020 dated 24.11.2020.

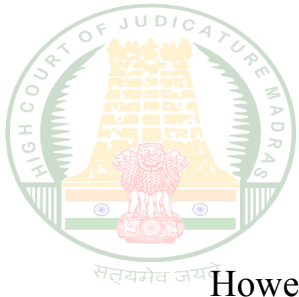
