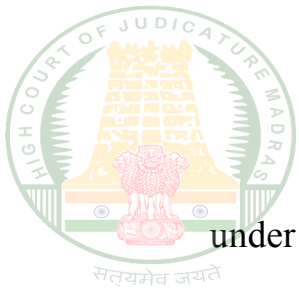

ORDER

2.According to the petitioner, he sent the representations dated 28.08.2024 and 17.04.2025 to the third respondent, but the same have not been considered. Hence this petition.

3.The learned Government Advocate (Crl.Side) appearing for the respondent police would submit that the petitioner's representations are
