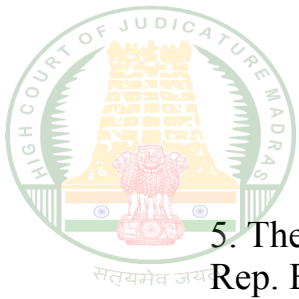

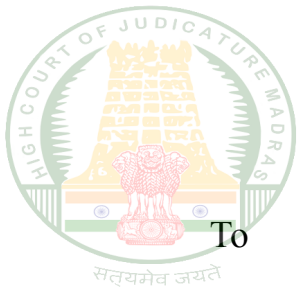
4th respondents for further investigation and to file a report before the concerned Court.
