ORDER

This writ petition has been filed by the petitioner to direct the respondents no.1 to 3 to consider the petitioner's representation dated 03.03.2025 and enquire the same and also give protection to worship the Temple, namely "Arulmigu Usikattu Sudalai Andavar Temple" situated at Neduvazhi, Radhapuram Taluk, Tirunelveli District.

2. According to the petitioner, he sent the representation dated 03.03.2025 to the respondent no.1 to 3, but the same has not been considered. Hence this petition.
