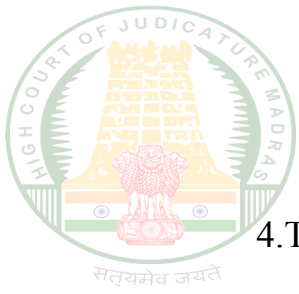
ORDER

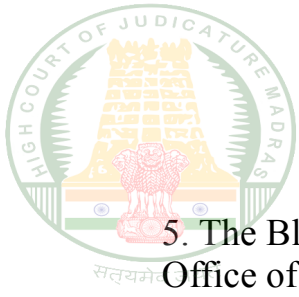
