The learned Government Pleader would submit that survey has been conducted in respect of S.Nos.71 and 149/71 and in respect of S.Nos.157, 158 and 162, the Authorities have to conduct survey and in the event of any encroachment, all appropriate actions will be initiated to evict the encroachers by following the procedures as contemplated under law.

3. In view of the above submission, the official respondents are directed to complete the survey and remove the encroachments, if any, within a period of twelve (12) weeks from the date of receipt of a copy of this order.

4. With the above direction, this Writ Petition stands disposed of. There shall be no order as to costs. Consequently, connected miscellaneous petition is closed.
