**PRAYER** : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Mandamus, directing the respondent Nos.1 to 4 to remove the encroachment made by the respondent Nos.5 and 6 by constructing the unauthorized commercial shop buildings and house in the earmarked park area namely Gandhi Park at Government porampoke land in Survey No.314/B situated at Pathamadaai, Cheranmahadevi Taluk, Tirunelveli District and restore the park for the welfare of the villagers by considering the petitioner's representation dated 02.04.2025 within the time stipulated by this Court.

2.The grievance of the petitioner is that his representation dated 02.04.2025, seeking removal of encroachments made by the respondents 5 and 6 by constructing unauthorized commercial shops and a house in the earmarked park area, namely Gandhi Park, situated on Government poramboke land in Survey No.314/B at Pathamadaai, Cheranmahadevi Taluk, Tirunelveli District and to restore the park for the welfare of the villagers, remains pending without any progress. Therefore, he has filed this Writ Petition seeking the aforesaid relief.

3.The learned Government Pleader appearing for respondents 1 to 4 submits that the representation of the petitioner will be considered and appropriate orders will be passed on its own merits within a time frame stipulated by this Court.

4.Considering the limited scope of the relief sought by the petitioner and without expressing any opinion on the merits of the petitioner's claim in the representation or the affidavit filed in support of the Writ Petition, we direct respondents 1 to 4 to consider the representation of the petitioner dated 02.04.2025, after giving sufficient opportunity of personal hearing to both the
