None for petitioner. Petition is dismissed. There shall be no order as to costs. Consequently, interim applications stand closed.

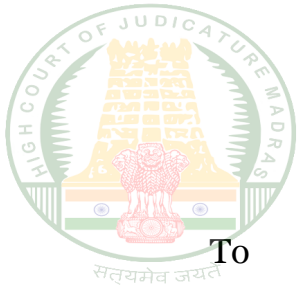
