Consequently, interim applications stand closed.

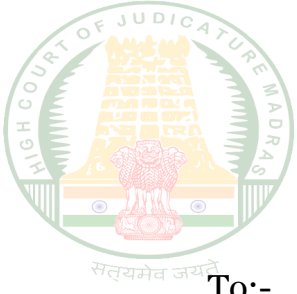
