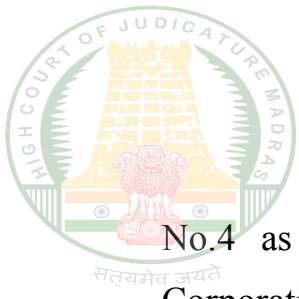

ORDER

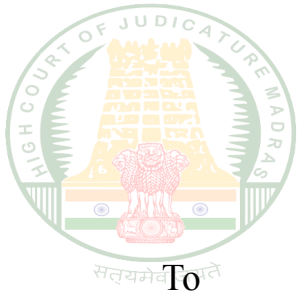
The challenge in this Writ Petition is relating to the transfer of the fourth respondent.
