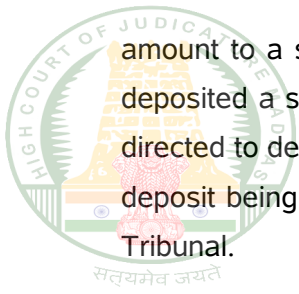

This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant M/s.K.R.Sivashankari and the counsel for the first respondent Mr.A.Sheik Nasurdeen are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Aggrieved by the award passed by the Tribunal, the Appellant/Insurance Company has filed the present appeal.

After due deliberations, both the parties have agreed into compromise and agreed to modify the award

amount to a sum of Rs.8,00,000/-(Rupees Eight Lakhs Only) towards full quit. The appellant has already deposited a sum of Rs.5,49,681/-, Rs.25,000/- and Rs.10,200/-(TDS) before the Tribunal. It is directed to deposit the remaining amount, within a period of One month from the date of the Order. On such deposit being made, the claimant is entitled to withdraw the amount, by filing formal application before the Tribunal.

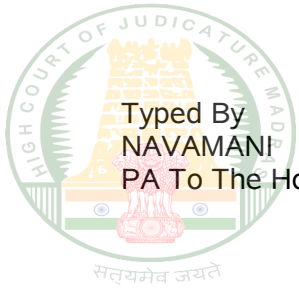
