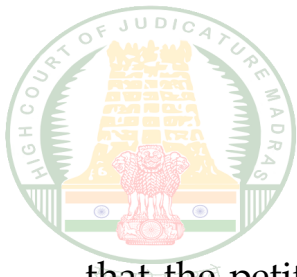
PRAYER :-
