ORDER : The Court made the following order :-

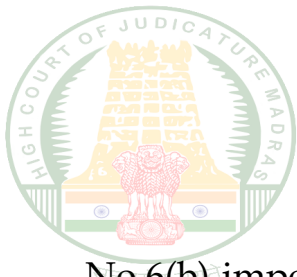
This Petition has been filed to relax the condition imposed in the order passed by this Court in Crl.O.P.No.350 of 2024 dated 09.01.2025.
