5.Considering the prayer sought for in this petition, recording the said submission that the petitioner's representation is pending with the third respondent, this Court directs the third respondent to conduct enquiry upon the petitioner's representation dated 03.02.2025 and take appropriate action, in accordance with law, within a period of fifteen days, from the date of this order, after affording opportunity to both the parties.

6.With the above observations and directions, this Writ Petition is disposed of.
