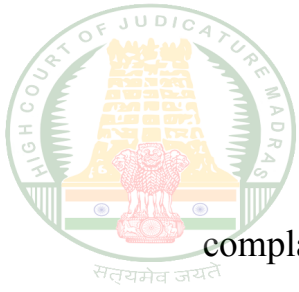

ORDER

This petition has been filed by the petitioners / accused to call for the records pertaining to the First Information Report in Crime No.213 of 2024 dated 18.10.2024 on the file of the first respondent police, for the offences under Sections 126(2), 127(2), 189(2), 296(b), 115(2), 118(1) and 351(3) of BNS, 2023 and Section 4 of the TN Prohibition of Harassment of Women Act, 2002 and quash the same.

2. When the matter was taken up for hearing, the learned counsels on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant, victims and all the accused are present and this Court enquired about the terms of compromise. The defacto-
