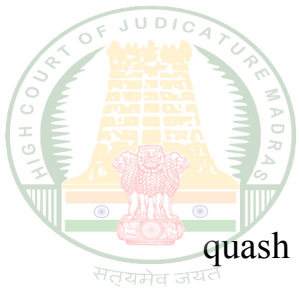

ORDER

This petition has been filed by the petitioners to call for the records pertaining to the First Information Report in Cr.No.71 of 2025 on the file of the first respondent police, for the alleged offences u/s.296(b), 115(2), 118(2), 329(4) of BNS and Section 4 of TNPHW Act dated 24.02.2025 and quash the same.

2. When the matter was taken up for hearing, the learned counsels on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant and all the accused are present and this Court enquired about the terms of compromise. The defacto-complainant

represented that they entered into a compromise and she has no objection to quash the FIR. A compromise memo, dated nil (filed on 28.04.2025) signed by the parties and their respective counsel, is also filed before this Court.

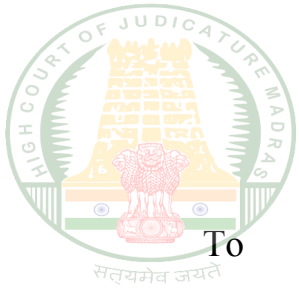
4. This Court has perused the terms of the compromise memo.
