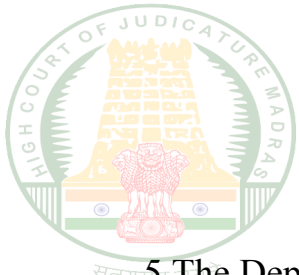

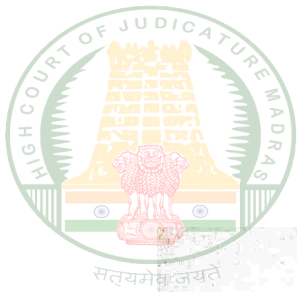

This writ petition is filed for Writ of Certiorarified Mandamus, to quash the impugned enquiry report ref. No. Nil dated 26.10.2024 received under Right to Information Act on 20.01.2025 and consequently direct the respondents 2 and 3 to conduct enquiry for professional medical abuse and criminal misconduct as per the complaint of the petitioner dated 22.09.2024 against the respondents 10 to 17 providing opportunity to the petitioner and her husband to participate in the enquiry.

2.Earlier, the case was posted for hearing on 15.07.2025. When the matter was taken up for hearing on 17.07.2025, this Court, after hearing the rival submission, was of the opinion that the party should compromise the matter themselves. Therefore, this Court advised the parties to compromise on the matter.

3.Today when the matter was taken up for hearing, it is submitted by all the learned counsels appearing for the parties that the parties have compromised the matter and the joint compromised memo is filed before this Court and the same is extracted hereunder:

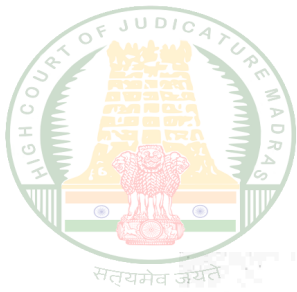

JOINT COMPROMISE MEMO

1. It is submitted that the 1st petitioner had filed a above writ petition before this Hon'ble court seeking direction to call for the enquiry report dated 26.10.2024 issued by the 4th respondent and quash the same and consequently prayed for further action against respondents 10 to 17. It is submitted that it is agreed before this

hon'ble court that both the parties ready to settle the issue amicably and report the same before this hon'ble court on 11.07.2025

2. It is submitted that in pursant to the above agreement both the parties that the petitioner and his husband namely nagoor kani and the 10th respondent/de-facto complainant were entered a compromise and settled their disputes out of court in an amicable manner. It is agreed upon by the petitioners and the 10th respondent/ De-facto Complainant that issue pertaining to the taking of scan by the petitioner in the 10th respondents scan centre on 18.09.2024 will not be agitated in any manner and before any forum by either parties. As per the compromise between the rival parties, the 10th respondent/de-facto complainant herein agrees to quash the Crime No. 206 of 2024 on the file of the 9th Respondent Police against the petitioner herein.

Hence, we prayed that this Hon'ble Court may be pleased to accept the compromise memo and quash the F.I.R. in Crime No.206 of 2024 on the file of the cumbum South Police station, Theni District pending against petitiners husband namely Nagoor Kani before 9th Respondent Police and pass such further or other orders as this Hon'ble Court may deem fit and proper to the circumstances of the case and thus render justice.

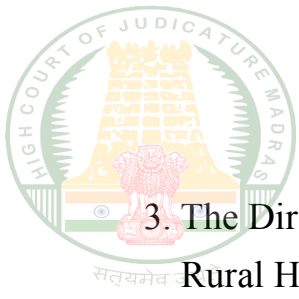
