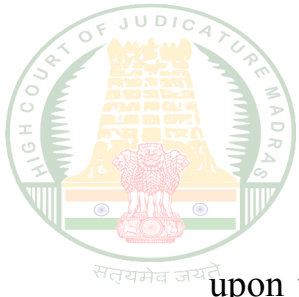
ORDER

The present Writ Petition has been filed by a retired Traffic Inspector of the respondent Corporation, seeking disbursement of the earned leave and surrender leave salary along with interest.
