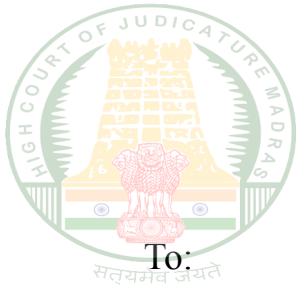
3. In view of the aforesaid submission, this writ petition is allowed.
