2. The learned counsel for the petitioner would submit that due to the civil dispute, the petitioner sent a representation to the second respondent on 17.04.2025, but no action was taken. Hence, she filed this petition.

3. The learned Government Advocate (Crl.Side) for the respondents would submit that there is a money dispute between the petitioner and one Selvam and Kanniyammal, due to which the opposite party lodged a complaint and the petitioner also lodged a complaint on 17.04.2025. Both the complaints are under consideration and they will consider the representation and take appropriate action in accordance with law.
